1. **PREAMBLE**

- 1.1 School and aftercare fees (“Fees”) are determined annually by the Centre’s management.
- 1.2 The Fees are set out in the Fee Payment Policy for 2021 to which this agreement is annexed.
- 1.3 Fees are due and payable in advance, on or before the last day of February. The Centre is prepared to accept payment of Fees in accordance with this agreement. No indulgence or latitude will be construed as a waiver or novation of any rights the Centre may have.

2. **UNDERTAKING**

- 2.1 I/We, the undersigned, hereby acknowledge liability for the annual Fees and I/we undertake to pay the applicable Fees for the year.
- 2.2 I/We further undertake to pay the Fees punctually in accordance with the provisions of this agreement;
- 2.3 I/We undertake to pay the Fees as follows (indicate your choice):
- 2.3.1 Single payment of the full annual amount
- 2.3.2 Twelve monthly payments with effect from 1 January to 1 December.

3. **DEFAULT**

- 3.1 Should I/we fail to make payments in accordance with this agreement, the balance of the year's Fees immediately becomes due and payable.
- 3.2 Should I/we fail to make payments in accordance with this agreement, the Centre may institute legal action against me/us for collection of the arrear Fees, in which event I/we will be liable for legal costs on the scale as between attorney and client, including collection commission and tracing fees;
- 3.3 Should I/we fail to return this agreement, duly signed, to the Centre by the last day of February, or in the event of enrolment of a learner after the end of February, within 10 days of enrolment, I/we shall be obliged to settle the Fees or indicate that fees will be settled over the remainder of the months in the year;
- 3.4 **Fees are due, owing and payable, notwithstanding periods of closure for circumstances outside of the Centre's control, including but not limited to public holidays, political unrest, intimidation, outbreak of infectious disease or a threat thereof at the Centre or for any other reason deemed necessary by the Centre for the safety of the learners and staff of the Centre.**

4. **GENERAL MOTHER/GUARDIAN**

- 4.1 Parents/Guardians shall be jointly and severally liable for payment of Fees.
- 4.2 Notwithstanding anything to the contrary contained herein or in any other agreement, the school reserves it right to terminate services to me/us for any reason whatsoever on 30 days' written notice to me/us.
- 4.3 No variation or amendment of this agreement will be of any force or effect, unless it is reduced to writing and signed by the parents/guardians and the school.
